The balance of the purchase price over the above stated deposit shall be payable in full before delivery of the completed **Trinka 12** at Builder's place of business, Vero Beach, Florida. Delivery elsewhere than Builders place of business will be at Purchaser's expense on a C.O.D. basis.

Any changes to the specifications indicated by Purchaser on the reverse side hereof will necessitate an additional charge to Purchaser, to be determined by the Builder depending on the nature of change and the stage of construction at which changes are requested. No changes will be made unless agreed to by Purchaser and Builder in writing.

Purchaser shall be entitled to inspect construction of his/her **Trinka 12** at any time, in person or through any duly appointed representative.

This written contract contains the entire agreement of Purchaser and Builder and no oral representatives or agreements shall be binding on either party.

BUILDER WARRANTS THE TRINKA 12 BUILT PURSUANT TO THIS CONTRACT FOR A PERIOD OF 10 YEARS AGAINST ANY DEFECT IN WORKMANSHIP OR MATERIALS SUPPLIED BY THE BUILDER. THIS WARRANTY DOES NOT COVER PARTS MANUFACTURED BY OTHERS THAN THE BUILDER, AND EXCLUDES ANY RESULTING OR CONSEQUENTIAL DAMAGES. WARRANTY IS LIMITED TO THE VALUE OF REPLACEMENT OF ANY DEFECTIVE PART.
